OSTLY, County Clerk of the County of Los Angeles, State of California, and ex officio Clerk of the Board of Supervisors of said County, do hereby certify that pursuant to a resolution of said Board of Supervisors adopted on January 6, 1953 (Minute Book 389, Page 158 et seq.) the proposition to form the Rowland Area County Water District under the County Water District Law, and the election of the first directors for the proposed district, was on February 17, 1953, submitted to the voters of territory described in the said resolution, and that said election was held on February 17, 1953, and that a majority of the votes cast at said election were in favor of the adoption of such proposition, and the following named persons, to wit: John M. Calleano, Cary G. Harris, Clarence E. Potratz, John A. Rowland, Jr. and Helen Walsh were elected as the first directors for the said district, as will more particularly appear from the certified copy of resolution attached hereto.

WHEREAS, in and by said resolution said Board further directed that notice of said election should be given as required by law and that the Clerk of said Board should issue and publish notice of said election for formation and for the election of the first Board of Directors of said district in the La Puente Valley Journal at least once a week for at least two weeks prior to said election;

WHEREAS, notice of said election was duly and legally given by the publication of notices as by said Code and said Resolution and Order of said Board directed:

WHEREAS, said election was held and conducted on the 17th day of February, 1953, and the polls at said election were duly open for the hours appointed therefor and votes of said election were cast, received and canvassed, and the returns thereof were made and declared in the time, form and manner as required by said Law and by said Resolution and in accordance with the law governing such election; and

WHERMAS, this Board has met on the 24th day of February, 1953, and has canvassed the returns of said election, as required by law, from which it appears that the said proposition for the formation of said district was duly submitted to the qualified electors of said proposed district and that the number of votes cast in favor of and in opposition to said proposition are as hereinafter set forth, and five directors for the Board of Directors of said district were elected as hereinafter set forth:

HOW, THEREFORE, IT IS HERELY FOUND, DETERMINED AND ORDERED, as follows:

1. That said election was duly called, held and conducted in the said territory on Tuesday, the 17th day of February, 1953, and the votes cast thereat were tabulated and the returns made and canvassed in the time, form and manner as required by law, and the proposition voted upon thereat was as follows:

"Shall the proposition to form Rowland Area County Water District under the County Water District Law be adopted?"

- 2. That for the purpose of holding said election one consolidated election precinct was duly established and provided, which precinct included the whole of said proposed County Water District, and was designated Rowland Area County Water District Special Precinct;
- 3. That at said election in said preciact the total number of votes cast was 142, of which total number of votes cast in said proposed district 128 votes were cast in favor of the adoption of said proposition, and 8 votes were cast against the adoption of said proposition;
- 4. That O duly registered voters, who expected to be absent from their respective election precincts on the day of the election secured ballots from the Registrar of Voters.
- 5. That the total number of votes cast in said district for and against the Proposition is as follows:

6. That at said election a majority of the votes cast within said proposed water district were in favor of the adoption of said proposition and the formation of said Rowland Area County Water District, and said proposition was duly adopted;

- 7. That the territory so proposed to be incorporated is hereby declared to be duly formed and organized under the name, "Rowland Area County Water District," pursuant to the County Water District Law (Division 12 of the Water Code, as amended, of the State of California);
- 8. That the territory comprising said district is situate in the County of Los Angeles, California, and particularly bounded and described in Exhibit "A" hereto attached and by reference made a part hereof.
- 9. The County Clerk of said County of Los Angeles shall immediately cause to be filed with the Secretary of State and recorded in the office of the County Recorder of said County, each, a certificate stating that said proposition for the formation of said County Water District has been adopted as provided by law, and that said County Water District has been duly formed; and the County Engineer shall cause a statement of the creation of said district, together with a map or plat showing the boundaries thereof, to be filed with the County Assessor of Los Angeles County and with the State Board of Equalization, as required by Sections 54900 to 54903, inclusive, of the Government Code.
- 10. That the candidates voted on in said election for the five offices of Director of Rowland Area County Water District and the votes cast for each of the candidates therefor were as follows:

- 11. That the following candidates, John M. Galleano, Gary G. Harris, Clarence E. Potratz, John A. Rowland, Jr., and Helen Walsh, being the five receiving the largest number of votes cast for Directors of said district, are hereby declared elected to the offices of Directors.
- 12. On behalf of the Board of Supervisors of the County of Los Angeles, the Registrar of Voters shall issue Certificates of Election to each of the successful candidates.
